Old Business:

July 2020 Minutes approved with no changes.

BLM statement discussion – (Summary presented by Daryl Thorne, author of Statement)

- First part of the statement was published in the Olney News in the June 27, 2020 edition; concern about the use of the word "demilitarization" in the second half of the BLM statement raised by a few Board members which lead to additional discussion → some concerns about "lumping demilitarization with defunding" expressed → clarification about the meaning of "demilitarization" and highlighting the fact that the word *defunding* was not in the Statement, *refund-allocation* was used and (re) explained in the context of re-orienting policing to treating people equitably.
- Full BLM statement (both parts) read to the general body, again; robust discussion held about the context and use of "demilitarization" connected to the intention of the BLM statement with additional information provided, again.
- Robin Z. (initiated the original idea of "demilitarization" as a component of the BLM Statement) → shared that the "concept of demilitarization is bigger than just equipment…indication that policing has gone awry in this Country".
- Full BLM statement accepted with a minor change to the second paragraph for clarification only; requested to be resent to Terri Hogan of the Olney News after the meeting to be printed in full; adopted by unanimous consent; Bim suggested putting this Statement on the SSCA website.

Ashton Sector Village discussion – (Summary of issue and need for Public Hearing position statement presented by Doug Farquhar and Kathleen Wheeler)

- Planning Board to meet on September 17th for a Public Hearing about the Ashton Village Sector
- Primary concerns shared by Doug & Kathleen → proposed plan regarding the southeast corning of NH Avenue/Rt. 108 "small homes on large lots east of Sandy Spring will stay large lots…"; no language about *transition* no site plan yet; may still have dense development next to less dense buildings; road infrastructure at intersection.
- SSCA Public Hearing position (draft) letter re-cap:
 - Supports keeping Ashton a Rural Village character zoning and height restrictions
 - Supports a shared use bike path and pedestrian at intersection
 - Crosswalks
 - Design a community advisory committee
 - Adequate transition to south and east
 - Support increased mass transit
- Process of letter writing discussed → Doug will take lead, Daryl to support, draft sent to Board for first look with Bim to sign off on; draft copy to be voted on at 9/14 meeting; final copy to be sent to Olney News and County Council.
